RULES AND REGULATIONS

Memberships:

- 1. Family or couple memberships consist of immediate family members residing in the same household. Children must be 22 or under.
- 2. Senior memberships are for ages 62 and over.
- 3. Everyone entering the YACTA facility must present membership cards at the front desk. Replacement cards are \$5.00.
- 4. The fee for guests is \$5.00.
- 5. All memberships are non-transferable and non-refundable.
- 6. Memberships may be frozen up to 3 months in a calendar year. Medical freezes may extend longer with a doctor's note. Annual memberships will not extend longer than 3 months for a non-medical freeze.
- 7. Memberships may be upgraded at any time.
- 8. All annual EFT memberships are for 1 year and automatically continue on a month to month basis.
- 9. There is a \$20.00 charge for returned checks or insufficient funds.

Use of the Facility:

- 1. Children may not be left unattended unless they are registered in a specific program. Children ages 1-12 must remain in ChildWatch, unless accompanied by an adult.
- 2. YACTA is not responsible for lost or stolen property. Theft reports & accident/incident reports should be made at the front desk.
- 3. Alcoholic beverages are not permitted on the premises at any time.
- 4. Illegally carrying or concealing a weapon or any device or object that may be used as a weapon into YACTA facility is prohibited.
- 5. Any form of harassment or intimidation or any type of menacing behavior is prohibited.
- 6. Sexually explicit or offensive conversation or behavior or any sexual contact with another person is prohibited.
- 7. Inappropriate, immodest, or sexually revealing attire, as determined by staff, is prohibited.

Tennis:

- 1. Tennis court reservations can be made up to 7 days in advance by calling or visiting the front desk staff. A 12-hour notice is required when canceling reservations. If notice is not given, the person who made the reservation will be billed for the court cost.
- 2. Fees must be paid in advance for all programs, court time, and lesson programs.
- 3. Members are asked not to step onto their assigned court until the beginning of their hour per cell phone time using coordinated universal time.
- 4. Random or contracts playing until closing will have a maximum of 15 minutes to use the locker room facility.
- 5. All random tennis reservations will pay random court time rates. We reserve the right to move any random and contract tennis court reservations for tournaments or special events with notice to the players.

Failure to abide by the Rules and Regulations established by YACTA may result in suspension or termination of your membership privileges. All policies are subject to change without prior notice. Any changes will be posted throughout the facility. Copies of these Rules and Regulations are available at the front desk and on the website.
